THE SIX-DAY TRAINING WAS TRANSFORMED TO A ONE-DAY INTENSIVE, BASECAMP. WITH FUNDING DIRECTED AT MAKING OUR BIGGEST IMPACT IN NORTHERN KENTUCKY, WE HELD THREE BASECAMPS IN THE FALL OF 2017. THE PRICHARD COMMITTEE ALSO CREATED A STATEWIDE PARENT LEADERSHIP AWARD, THE BEVERLY NICKELL RAIMONDO LEADERSHIP AWARD. OUR FIRST AWARD WINNER WAS RECOGNIZED AT OUR ANNUAL MEETING IN OCTOBER OF 2017.
